Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;

The school Emergency Preparedness Plan includes procedures for emergencies such as fire, earthquakes, lockdowns, and intruder alerts. The VRB Safety Plan is available in the school office, and is reviewed with all staff during one of our staff meetings. Our school participates in monthly drills that take place for fire, earthquake, and lockdowns. Emergency preparedness trainings for all staff members take place annually; as a district and school we will be implementing the ALICE strategies in case of an active shooter on campus.
